Capstone Community Action- State got a grant for Case Management- Capstone trying to hire-Hired Tim Brown-Southern Baptist Relief Disaster Relief Coordinator with be the Construction Manager- One Disaster Case Manager- - We are supposed to have 3 Case Managers- now time line mid to late January. Also talked with Capstone about sharing and information technology. We do have 3 laptops.

Still need to have hard line for internet access.

Catholic Charities- 10 K grant for direct support to flood victims- Still waiting for word-should be by 15 DEC.

VT Community Foundation- up to 50K sent back requests for more information. This week received \$35.000.00 into a flood disaster fund to support the Hope Coalition.

Upcoming Teams.

Nick- First out of state contractor- Electrical Contractor- has been doing electrical work and estimates for FEMA. We are finding out the correct path as we are the first agency to utilize out-of-state contract workers who can be allowed to work in the state.

TY- Steve Spatz -State of VT has agreed to work with us to train for Efficiency VT rules so that our people will be trained and contractors can be paid in 2 weeks for work that is done. To tie the with GMP heat pumps generally require a second electrical panel to support a heat pump for the home. They have been receptive to using our volunteers to provide additional support to them to move the process along to get people with heat and electricity.

Mennonite Disaster Relief may come back once we have work organized. Also Team Rubicon has committed to days in January. Hyde Point Church confirmed days in January - church in NH with come back-had previously worked on Second Street.
